Please use this checklist if you desire to sell or purchase a manufactured home located in Sunnyside Mobile Home Park SELLER must complete the MHCO Form 11 10 Day Notice of Intent to Sell Manufactured Home and turn it into the office. BUYER must apply to become a Tenant before purchasing a home in the park by picking up a Prospective Tenant Application packet and instructions from the office. Forms are to be completed but not signed. BUYER must schedule an appointment with the Manager where they will bring a copy of their valid government issued photo ID, provide proof of income, sign all application documents in the presence of management, and pay a \$100.00 per person fee for the credit and background checks. This process may take up to 7-20 days. Sunnyside Mobile Home Park will notify BUYER of the decision. If tenancy is pre-approved, this is what is needed in order to move forward: BUYER SELLER SELLER or BUYER need to get an inspection on the MH from an Oregon licensed Home Inspector. The report is to be sent to Sunnyside Management for review. After the repairs are completed, a re-inspection is required. (The initial inspection report and the re-inspection report need to be signed off by Park Management.) SELLER will be given the MHCO Form 53 Re-Sale Compliance, and photos from Management indicating any repairs that the MH and rented space requires before the sale of the home may commence. Any and all needed repairs are agreed upon between the SELLER and BUYER. Repairs noted on the MHCO Form 53 Re-Sale Compliance form need to be completed before closing the sale of the MH and rented space. unless approved in writing by Manager, noting a completion date. BUYER will need to make an appointment with the Manager to complete the legal documents to become a Tenant before closing on the purchase of the MH and rented space. Once BUYER is approved and has signed all legal documents with the SMHP management to be a Tenant of the Park, then SELLER may sell the MH to **BUYER** and transfer title.

NOTE: PURCHASE OF THE MH OR CHANGE OF TITLE CANNOT BE MADE UNTIL ALL OF THE ABOVE HAS BEEN COMPLETED AND SIGNED OFF BY SUNNYSIDE MANAGEMENT.
